The adverb of manner is filled in the sentence structure in the form of adverb of manner and prepositional phrase. Suffix —Iy can be in the positive form of the adjective. The form of adverb of manner is in the prepositional phrase characterized by a preposition as the head of adverbial.

I. Introduction

There are a question, subject and statements that are usually by word and it usually contains a subject and a verb. Phrases and sentences can be built up from constituent series (syntactic units) that can be served as grammatical function. There are arrangements and the form of word that can be related in a sentence. Many words can build some sentences in English as one unit. There are subject, verb, complement, object and adverbial (SVCOA) that can be found in a sentence. An adverb of manner can be found in the initial, medial and final position in a clause. Adverb of manner is usually formed from an adjective and followed by -ly suffix. An adverb of manner in the form of prepositional phrase is formed from preposition, followed by a noun phrase. The examples of adverbs of manner are *enviously*, *quickly*, *desperately*, and *hurriedly*. It can be seen that an adverb of manner explains about how the subject does an activity. An adverb of manner can provide more information about the manner, time, place,

frequency, or certainty. Adverbials are stated as the words groups in which an adverbial phrase can give us more informations about the verb. Adverbs of manner are in the forms of adverbs, adverb phrases, or prepositional phrases. Some classifications in adverbial are classified as an adverb of manner.

The theory that was used to analyze the form and position of adverb of manner was proposed by Brown and Miller (1992). It explained about adverb of manner in which the event can be described by the verb. An adverb of manner provided more informations about how the event is described by the verb. Adverbial of manner can analyze on how an action can be performed. It can be seen that an adverb of manner is formed by an adjective followed by -ly suffix. Adverb of manner is formed by adding 'ly' to an adjective.

It is stated that an adverb of manner can also be formed by an adjective, adverb phrase and prepositional phrase. By using the constituent structure presentation, an adverb of manner can be analyzed. The sentence structure is stated as syntactical identification by analyzing the constituent structure. The adverbial of manner can fill in some variations of its position. Adverb of manner can be positioned in the initial, medial, and end position. Brown and Miller (1992:95) stated that, adverbs of manner are stated as the items that most readily spring to mind as examples of the class adverb, especially those that are formed by the –ly suffix to a corresponding adjective form:

Happy → happily (Brown and Miller, 1991:95)
 Vicious → viciously (Brown and Miller, 1991:95)

Brown and Miller (1992:94) stated that, adverb of manner indicated the manner in which the event described by the verb is carried out:

- 1. The dog bit the man *viciously* (Brown and Miller, 1991:94)
- 2. The man beat the dog *viciously* (Brown and Miller, 1991:95)
- 3. The man beat the dog *viciously* in the garden yesterday (Brown and Miller, 1991:95)

The form of adverb of manner in prepositional phrase is characterized by the preposition as the head of adverb of manner. Brown and Miller (1992:94) stated that, adverbs of manner are typically a prepositional phrase, as follows:

- 1. The man beat the dog *in a vicious manner* (Brown and Miller, 1991:94)
- 2. The man beat the dog with apparent enjoyment (Brown and Miller, 1991:94)
- 3. John stood on his head *with difficulty* (Brown and Miller, 1991:94)

There are three positions of adverb for the declarative form of the clause. Adverb of manner is placed in the initial position, medial position and final position. In the initial position, adverb of manner is placed before the subject. In the medial position, an adverb of manner comes before the verb. In the final position, adverb of manner is placed after an intransitive verb or any object and complement.

II. Methods

The novel entitled "Harry Potter" was used as the data source as there are many data of adverb of manner which were found in the data source. The data were collected through reading the data source found in the novel entitled "Harry Potter" in order to get the data of adverb of manner. The parts of research method are called as the data source, method and technique of collecting data and method and technique of analyzing data. The data sources and method and technique of collecting data can be the procedures used to collect certain data of adverb of manner. It analyzed the data taken from the sources and analyze data of adverb of manner found in the data source. The research was applied in the field of observation. 

a. Form



An adverb of manner *enviously* is an optional because it is not required by the verb of a sentence to form well sentence in the structure. It has function in the nucleus *Ron moaned*. In the process of the suffixation, adverb of manner is formed by: *quick+* (-ly) suffix becomes *quickly*. It can be



An adverb of manner *quickly* is VP modifier. The NP *They and VP left* are part of the constituent structure above.

An adverb of manner *desperately* is an optional because it is not required by the verb of a sentence to form well sentence in the structure. It has function in the nucleus *Harry said*. An adverb of manner *desperately* is VP modifier. The NP *Harry* and VP *said* are part of the constituent structure above.




b. Position

a. Form



a. Form






